VOTING FROM 14 JUNE TO 14 JULY 2021

IN THE DISTRICTS SPACES ESPECIALLY DESIGNED

What It is: it is an official organization representing non-EU citizens and stateless persons legally resident in the Municipality of Padua and not having Italian and /or other EU citizenship; it will be composed of 16 elected representatives.

The function: it is an advisory organism for the Mayor, the Executive, the Municipal Council, the Council Commissions and the district Councils. The Commission can present to them opinions on the proposed resolutions and submit its own proposals on everything concerning the administrative life of the city.

Who can vote all the people who, on June 14, 2021, are:

- citizens of a state that is not part of the European Union or stateless;
- have a valid identity document;
- over 18 years old;
- registered in the registry of residents of the Municipality of Padua.

Who can submit a candidacy: foreign citizens/residents in the Municipality of Padua if they are:

- citizens of a non-European Country or stateless;
- have a valid identity document and a valid residence permit or in renewal process;
- over 18 years old;
- registered in the register of Padova's residents;
- not in the conditions written in article 10 of Legislative Decree 235/2012, that is regulations on the inability to candidate and the prohibition to hold elective positions.

How to apply: those who intend to apply can declare their intention until 14 May 2021 using the appropriate form available on the website www.padovanet.it. The form, correctly filled and signed in all its parts in Latin characters, together with a passport-size photo and a copy of an identity document and a valid residence permit or in the process of being renewed, constitutes the personal application form.

Each candidacy must be signed in Latin characters by at least 20 voters. Each voter can only subscribe to one nomination. It is up to each candidate to collect the subscriptions to their candidacy and copies of the related documents.

The candidate application form, together with the required documentation, must be submitted to the 'Ufficio Protocollo Generale del Comune di Padova" in one of the two following ways:
